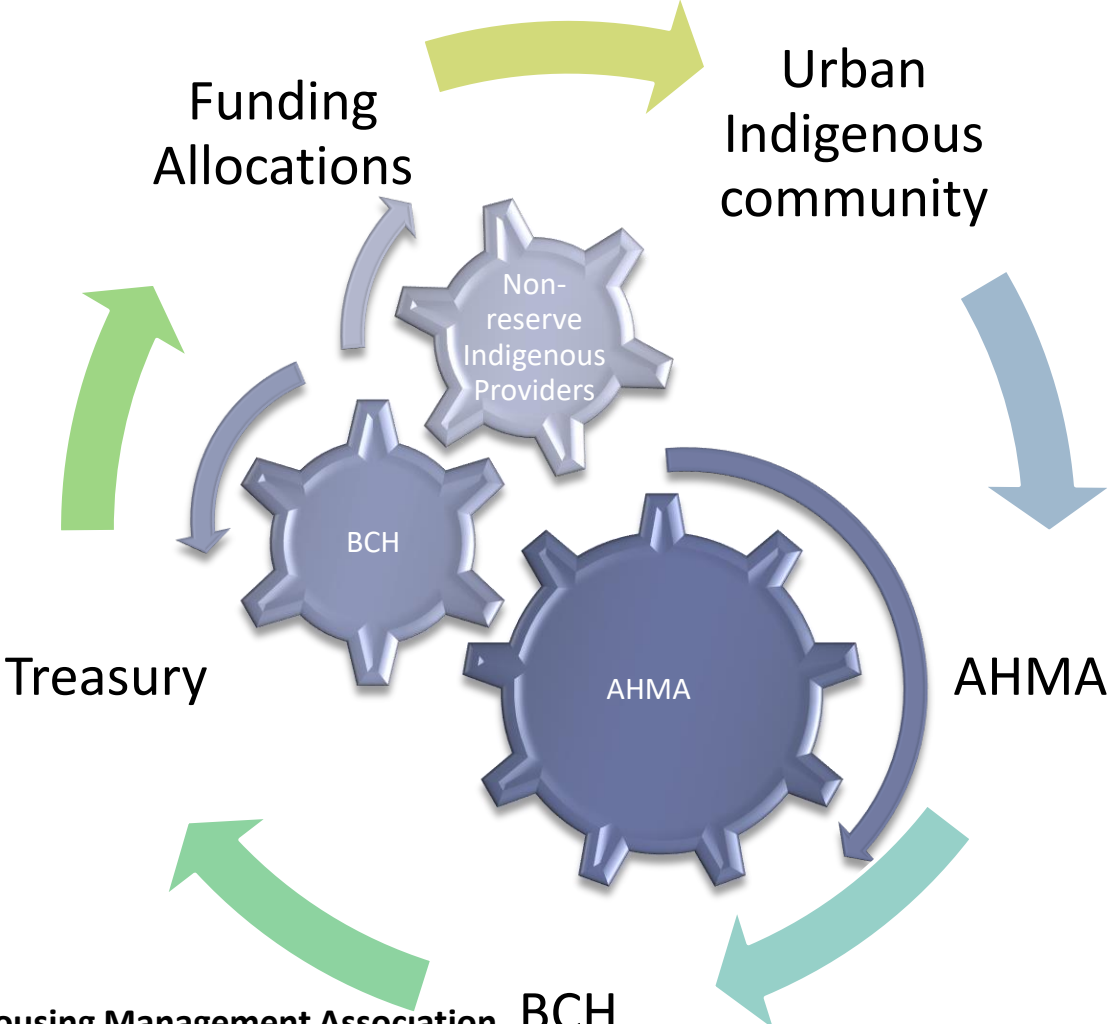
About us:
