4. Joint Report of the President and Executive Director

Tim Crooks and Jeff Morrison, Executive Director, CHRA, shared that the Joint Report of the President and Executive Director was outlined in the Annual Report and AGM package. Tim Noted his regret that CHRA was forced to host the Congress virtually yet again, and his sincere hope that pandemic conditions will be safely together in person again soon. CHRA demonstrated strong influence in 2021 with the federal election, federal budget and consultations on our Blueprint for Housing. CHRA also became the administrative home for the Chartered Institute of Housing – Canada, in 2021. CHRA's top priority remains in pursuing an urban, rural and northern Indigenous housing strategy, led by the CHRA Indigenous Caucus.

Justin Marchand, Chair of the Indigenous Caucus, commented on the Caucus' advocacy efforts over 2021, and the importance of a for-Indigenous, by-Indigenous housing strategy.
