The Senior Manager of Education works with the Executive Director, CHRA membership and CIH membership to foster the next generation of housing professionals, and to foster connections and a community of practice toward housing leadership in Canada.

#### **Responsibilities:**

#### Strategic Planning

- In consultation with the CIH Canada Board of Directors and CHRA staff, plan and execute a CIH Strategic Plan outlining goals and objectives for CIH Canada.
- Prepare and execute an annual business plan outlining the measures that will be taken to implement the Strategic Plan goals.
- Develop a membership growth strategy designed to increase the membership of CIH Canada.

### **Program Management**

- Lead budgeting, planning and logistics for all CIH-C programs, events and courses.
- Serve as a liaison with members and represent their needs.
- Manage the training offerings and activities in Canada.
- Respond to inquiries about CIH Canada.
- Oversee the business and financial operations of CIH Canada.
- Oversee that accreditation requirements for members are maintained.
- Organize compatible CHRA education, training and professional development programs.

#### **Governance and Accountability**

- Prepare and organize meetings of the CIH Canada Board of Directors and Executive Committee.
- Report to the CIH-C Board and Executive on relevant actions and progress towards strategic goals

 Report to the CHRA Board on CHRA and CIH co-managed programs, and opportunities to strengthen member value through CHRA and CIH-C collaboration.

#### **External Relations**

- Develop strategic partnerships to promote and expand CIH Canada.
- Work with the CIH (UK) policy team to ensure local, Canadian issues are fed into the overall policy work and that CIH (UK) positions are promoted in Canada, when applicable.
- Liaise with post-secondary institutions to grow educational offerings.
- Oversee promotional and communications opportunities to expand knowledge of CIH Canada.

#### Qualifications

- Minimum 5 years' experience in managing programs, ideally in a national association setting.
- Post-secondary degree, preferably related to education, or housing and homelessness.
- Excellent English communication skills, including writing and verbal skills.
- Highly organized and offers exceptional attention to detail.
- Excellent customer service ethic and high expectations for quality.
- Ability to work as part of a team.
- Excellent interpersonal skills, strong relationship management, with a high level of professionalism.
- Ability to accomplish projects with little supervision.
